LIMITED WARRANTY FOR INFLATABLE NIGHT FOOT / GOLF TARGETS

1 Year Electronics Warranty

1. We will warranty the electronic base of each new night golf, foot golf target (hereafter referred to as "Product") manufactured by us, to be free from defects in material and workmanship for a period of 1 year from date of purchase.

This warranty is as follows: A one (1) year warranty on the electronic base and six month (6 Month) warranty on the lithium battery.

- 2. If any product is purchased or used for in an environment that is operated for more than 8 days per month, then the term of this Limited Warranty is limited to a period of ninety (90) days after the date of original retail purchase.
- 3. Since this warranty applies to defects in material and workmanship, it does not apply to normal wear and tear or to damage caused by:
- 3.1. Rust due to prolong exposure to moisture.

- 4. It is the purchaser's responsibility to inspect each target upon delivery for any punctures, tears, or leaks. Any defects must be made within 7 days of delivery.
- 4.1. Since this warranty applies to defects in material and workmanship, it does not apply to normal worn fabric or to damage caused by:
- 4.2. Neglect, lack of maintenance, accident, or abnormal operation.
- 4.3. Normal discoloration, dulling, or crazing of the fabric;
- 4.4. Abrasions, tears, punctures, or normal color fading;
- 4.5. Damage to or deterioration of the fabric due to UV exposure;
- 4.6. Damage or deterioration of the fabric due to alterations, exposure to fuel, harsh solvents, or other chemicals;
- 4.7. Seam separation / cracking due to exposure to extreme heat or cold.
- 4.8. Has been abused, misused or improperly operated or over-inflated.
- 4.9. Has been damaged as a result of shipping, warehousing, or storage.
- 5. Claims shall be made under this warranty by calling 866-661-0145 for an RMA prior to delivering the Product for inspection to *Premier Glow 144 Mid South Cv*, *Collierville TN 38017*, provided such service is covered under this warranty. Purchaser shall pay for all related transportation charges. *All shipping expenses related to a warranty claim are the Purchaser's responsibility*. If the service is not covered by this warranty, purchaser shall pay for all related labor and material and any other expenses associated with that service. Any Product or parts shipped by purchaser for inspection or repair must be shipped with transportation charges prepaid.
- 6. Premier Glow obligation under this warranty shall be limited to repairing a defective part, or at our option replacing such part or parts with new or refurbished parts as shall be necessary to remedy and malfunction resulting from defects in material or workmanship as covered by this warranty. We reserve the right to improve or change the design or any product without assuming any obligation to modify any product previously manufactured.
- 7. All incidental and consequential damages are excluded from this warranty. Implied warranties are limited to the life of this warranty.
- 8. This warranty gives you specific legal rights, and you may also have other legal rights, which may very from area to area.

- 9. Please note that in an unlikely event that received merchandise, or any of its parts need to be replaced for any reasons Premier Glow will deliver replacement parts to the Freight Forwarder of your choice ONLY within the lower 48 states. Customers outside of US are responsible for shipping, customs and duties charges associated with shipping of merchandise from US to destinations abroad. Premier Glow will not be responsible for shipping, duties or taxes charged for shipments outside of the US.
- 10. We will pay for the 2 way shipping within 7 days of a delivered purchase if the purchased item is defective or an error in shipping has been made on our part. After 7 days, we will pay for the return shipping fee within 90 days of purchase. Customer will pay for 2 way shipping fee after 90 days when warranty service is required.
